The Issue: A Growing Need for Age-Friendly Services

Miami-Dade County is home to a rapidly growing older adult population. As these residents age, the demand for accessible, age-friendly services, transportation, and health support increases. The Miami-Dade Age-Friendly Initiative (AFI), now in its 13th year, is working to meet these needs, ensuring that all older adults can live with dignity, health, and quality of life. We need your support to sustain and expand these efforts.

About the Miami-Dade Age-Friendly Initiative

The AFI is a collaborative effort involving key partners such as Urban Health Partnerships (UHP), AARP Florida, United Way Miami, Miami-Dade County, the Miami-Dade Transportation Planning Organization, and the Alliance for Aging, among others. The initiative uses a 5-year recertification process, integrating community feedback through Needs Assessments and leveraging the AARP's 8 Domains of Livability to develop strategic actions and co-create positive impact. This ensures that our strategies address real challenges, such as transportation, social isolation, and access to health services.

AFI Focus: Policy, Systems & Environmental Change Solutions

-  **Creating Age-Friendly Public Spaces**
Expand accessible parks, community centers, and public spaces by supporting Age-Friendly Park Certification and ADA-compliant infrastructure.
-  **Improving Transportation for Older Adults**
Enhance mobility options by funding shuttle services, transportation vouchers, and advocacy for accessible transit designed with and for older adults.
-  **Advancing Age-Friendly Policies & Systems**
Support policy updates and community initiatives that improve safety, accessibility, and services for older adults across Miami-Dade.
-  **Combating Social Isolation**
Help older adults stay connected by funding engagement programs and community activities through the AFI Older Adult Advisory Committee.
-  **Empowering Older Adults in Decision-Making**
Give seniors a voice by supporting education and advocacy events that equip them to influence policies and community decisions.
-  **Expanding Access to Health Services**
Improve healthcare access for older adults by funding mobile clinics, telehealth programs, and peer support networks.

Funding Area	Investment Needed	Impact
Expand Public Space Accessibility	\$50,000	Fund the expansion of the Age-Friendly Park certifications and support the implementation of ADA-accessibility improvements to public space infrastructure
Enhanced Transportation Services	\$75,000	Support the expansion of the Age-Friendly transportation infrastructure by partnering with County and City agencies to enhance accessibility, improve transit options, and invest in vital infrastructure improvements
Implement Age-Friendly Policies & Systems	\$50,000 - \$100,000	Fund the relaunch of the Age-Friendly Housing Policy Report & Improvements to the Library Certification Program
Social Engagement Programming	\$45,000	Reduce isolation and expand activities for older adults to actively participate in decision making in their communities with Older Adult advisory groups and task forces.
Annual Education & Advocacy Event	\$30,000	Educate and empower older adults by funding the Annual AFI Capacity Building Event, which provides training on age-friendly initiatives, livability, advocacy, policies, and essential community resources.
Mini-Grant Program	\$25,000 - \$50,000	To re-launch and manage the AFI Mini-Grant Program, funding innovative, community-led projects that drive meaningful, long-term age-friendly progress.
